

Terms and Conditions

Agreement between User and www.affordablebuses.com

Welcome to www.affordablebuses.com. The www.affordablebuses.com website (the "Site") is comprised of various web pages operated by Affordable Charter LLC ("Affordable Charter"). www.affordablebuses.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of www.affordablebuses.com constitutes your agreement to all such Terms. Please read these terms carefully and keep a copy of them for your reference.

www.affordablebuses.com is an E -Commerce Site.

[Affordablebuses.com](http://www.affordablebuses.com) is the official website of Affordable Charter LLC, a transportation company that provides group travel solutions in the Tri -State area. The website allows customers to request quotes and book transportation services, including full -size charter buses, minibuses, and passenger vans for group trips, corporate events, school outings, airport transfers, and private charters. We do not sell physical products; instead, we offer professional transportation services, describe our fleet and service options, and provide contact information so customers can plan and organize their trips efficiently and safely.

Electronic Communications

Visiting www.affordablebuses.com or sending emails to Affordable Charter constitutes electronic communications. You consent to receive electronic communications, and you agree that all agreements, notices, disclosures and other communications that we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing.

Children Under Thirteen

Affordable Charter does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use www.affordablebuses.com only with permission of a parent or guardian.

Payment and Deposit Terms

For all trips, a \$500 deposit is required to secure and confirm the vehicle reservation/booking. This deposit is due at the time of booking, reserves the specific date, time, and vehicle requested, and will be applied toward the total balance due for the trip in accordance with the payment and cancellation terms set forth in this Agreement.

Full payment must be submitted prior to the trip date. All payments made by credit card are subject to a 4% credit card processing fee.

Cancellation/Refund Policy

Cancellations made 14 days or more prior to scheduled garage departure: Full refund issued; no penalty.

Cancellations made within 14 days of scheduled garage departure: A \$500.00 cancellation fee applies per reservation.

Cancellations made within 96 hours of scheduled pickup time: No refund will be issued.

All cancellations must be received in writing via email or other approved method.

Insurance

Affordable Charter LLC maintains at least the following vehicle liability insurance coverage during the term of the Service Contract:

For vehicles with a maximum capacity of up to fifteen (15) passengers (including the Driver): \$1,500,000 combined single limit (or equivalent).

For vehicles with a maximum capacity of more than fifteen (15) passengers (including the Driver): \$5,000,000 combined single limit (or equivalent).

For claims arising out of the Transportation Services provided under the Service Contract, Affordable Charter LLC's vehicle liability insurance will generally be primary, subject in all respects to the terms, conditions, limitations, and exclusions of the applicable insurance policies.

DOT & FMCSA Regulations

All trips must comply with FMCSA hours-of-service (HOS) regulations: The itinerary must fit within a 15-hour on-duty limit per driver per day; Drivers may drive no more than 10 hours within the 15-hour duty window; Time must include: 30 minutes for pre-trip inspection, and garage-to-pickup and drop-off return travel time. The company reserves the right to modify itineraries that do not comply with federal regulations. It is the charter party's responsibility to ensure event schedules fit within legal limits.

No Unlawful or Prohibited Use/Intellectual Property

You are granted a non -exclusive, non -transferable, revocable license to access and use www.affordablebuses.com strictly in accordance with these terms of use. As a condition of your use of the Site, you warrant to Affordable Charter that you will not use the Site for any purpose that is unlawful or prohibited by these Terms. Indemnification

Arbitration

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.

Further, unless both you and Affordable Charter agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
